

Important Information About Your 2026 Bill

Thank you for choosing Peoples Gas to deliver safe and resilient natural gas to your home. We are committed to safely and efficiently serving our customers while prudently managing our operations. In August, Peoples Gas filed a joint motion with intervening parties, including the Office of Public Counsel, requesting the Florida Public Service Commission (PSC) approve a settlement agreement that resolves all issues in our rate request proceeding. The PSC approved the settlement this fall, resulting in an overall increase that is less than we originally proposed. Impacts to the Customer Charge and Distribution Charge portions of your bill, as well as other charges which are adjusted annually, are outlined below.

Typical components of a residential bill

- **Customer Charge** – This fixed monthly amount covers the cost of providing service to your location.
- **Distribution Charge** – This is a grouping of several costs including your base rate, a charge for energy conservation programs, pipeline replacement and other costs. The portion of the distribution charge that will increase as a result of our rate request is the base rate. The other portions are adjusted annually. In 2026, charges for pipeline replacement will increase and conservation programs will decrease.
- **PGA Charge** – The Purchased Gas Adjustment (PGA) is the cost of gas purchased for you by Peoples Gas. This charge is passed through from suppliers to consumers and can fluctuate monthly within an approved range based on the price of natural gas. We do not mark up or profit from this charge. Because of projected increases for the cost of natural gas, we are increasing the current PGA range cap from \$1.00135 per therm to \$1.16057 per therm for 2026. This does not necessarily mean your monthly rate will increase.
- **Florida Gross Receipts Tax** – Utilities collect this tax from customers and remit it to the state without markup.
- **Franchise Fee** – Similar to taxes, this fee is collected from customers and remitted to a municipality.

** Effective Jan. 1, 2026, the RS-1 rate class will be closed to new customers. Existing RS-1 customers will continue to bill on this rate as long as their annual usage is less than 99 therms. Rate classes RS-2 and RS-3 will be combined into one rate class, RS-2, for residential usage up to 1,999 therms per year.*

The above rates do not reflect the Purchased Gas Adjustment (PGA).

Rate schedules are subject to gross receipts taxes, city and state taxes and franchise fees, where applicable.

Base rates are part of the Distribution Charge line item on your bill.
